## Related links

As in previous years, we propose to provide the International Insurers Department (IID) of the National Association of Insurance Commissioners (NAIC) with extracts from the Quarterly Monitoring Return (QMA) as an acceptable alternative to the data which would otherwise be collected from syndicates in the IID standard filing format. The provision of this data from the QMA forms will be made centrally by Lloyd's, to keep the reporting burden on the market to a minimum. The requirements for actuarial reports, Jurat, interrogatories, audited annual financial statements and the balance of the IID financial filing format (which must be notarised) will continue.

The purpose of this letter is to seek your permission to provide the IID with the QMA forms relating to the Quarterly Monitoring Return due in on 20 February 2014.

I should be grateful if you would complete the attached form and return it to the market reporting mailbox <u>Lloyds-MR-Overseas Reporting</u> by 6 March 2014. Further details on the 2013 year end NAIC/IID filing requirements will be issued, shortly after final confirmation from the IID is received.

Please note that any extracts provided to the NAIC/IID will be on the public record.
