As in previous years, the International Insurers Department (IID) of the National Association of Insurance Commissioners (NAIC) annual filing has been drafted such that that the Annual Return (AR) and FSA Return forms (previously the SR forms) would provide an acceptable alternative to the data which would otherwise be collected from syndicates in the IID standard filing format. The provision of this data from the AR/FSA forms will be made centrally by Lloyd's, to keep the reporting burden on the market to a minimum. The requirements for actuarial reports, Jurat, interrogatories, audited annual financial statements and the balance of the IID financial filing format (which must be notarised) will continue.

The purpose of this letter is to seek your permission to provide the IID with the AR/FSA forms relating to the two submissions (i.e.: the AR due on 2 March 2006 and the FSA return due on 13 April 2006).

I should be grateful if you would complete the attached form and return it to this department by **Thursday 9 March 2006**. Further details on the 2005 year end NAIC/IID filing requirements will be issued, shortly after final confirmation from the IID is received.
