Purpose of bulletin

To inform the market of a change in Lloyd's Attorney in Fact for Underwriters in Kentucky with effect from 1 August, 2006.

Lloyd's Kentucky, Inc.

Jim Lamb, the current Attorney in Fact, retires from this role on 31 July, 2006. Lloyd's Kentucky, Inc will be established and will become the corporate Attorney in Fact for Lloyd's underwriters in Kentucky from 1 August, 2006. The Kentucky Office of Insurance has been advised of this change.

Pat Talley has been appointed President of Lloyd's Kentucky, Inc and will commence this role from 1 August, 2006. Until then, Pat will be Executive Assistant to the Kentucky Attorney in Fact. Pat joins Lloyd's Kentucky, Inc. from the Kentucky Office of Insurance, where he was Chief Financial Analyst responsible for overseas, domestic and foreign licensed insurers in the state.
